A representative of my clients has previously informed the senior staff of the Office of Enforcement about the existence of this website. The password is required both to access the site and to view the videos on the site.

If the Office of Enforcement goes forward and makes the investigation public, Powhatan will release the website to the public and actively promote it, so that the principals of Powhatan and Huntrise can protect their reputations. Furthermore, if the Office of Enforcement issues any additional subpoenas or requests for information to Powhatan, Huntrise, Dr. Alan Chen or any of Powhatan's independent experts, Powhatan may go public with the website.
