**DEFENDANTS’ UNOPPOSED JOINT
MOTION FOR AN EXTENSION OF TIME**

Defendants Powhatan Energy Fund LLC, Houlian Chen, HEEP Fund, Inc., and CU Fund, Inc. (“Defendants”), hereby jointly move, pursuant to Federal Rule of Civil Procedure 6(b) and Local Civil Rule 7(F)(2)(b), for an extension of time to file their rebuttal briefs in support of their motions to dismiss, and in support state as follows:

1. Defendants filed their motions to dismiss (ECF Nos. 20, 22) on October 19, 2015.
2. Plaintiff filed its oppositions (ECF Nos. 28, 29) to Defendants’ motions to dismiss on October 30, 2015.
3. Defendants’ rebuttal briefs in support of their motions to dismiss are presently due by November 5, 2015.
4. Several of Defendants’ counsel will be traveling for other matters from November 1 to November 4, 2015.
