Dear Acting Chairman LaFleur and Commissioners:

I represent Powhatan Energy Fund LLC and Huntrise Energy Fund LLC in the above matter. As you know, Norman Bay has been nominated to be a FERC Commissioner and the White House has indicated that the President plans to designate him as the next FERC Chairman. After testifying at his nomination hearing on May 20, 2014, before the Committee on Energy and Natural Resources, Mr. Bay responded on June 4, 2014, to written Questions for the Record posed by members of the Committee. In response to Question 3 from Senator Lisa Murkowski regarding the above investigation, Mr. Bay explained that he had to remain silent about Powhatan and Huntrise unless the Commission authorized him to speak about them. On behalf of Powhatan and Huntrise, I respectfully ask that you please give him that authorization immediately.

More specifically, pursuant to 18 CFR § 1b.9, you may direct or authorize the public disclosure of Powhatan and Huntrise's involvement in the above investigation. Powhatan and Huntrise waive all rights to keep the investigation non-public and ask that you direct Mr. Bay to discuss Powhatan and Huntrise with the Committee and therefore answer any questions that Senator Murkowski or other Senators on the Committee have about the investigation. Moreover, Powhatan and Huntrise have already publicly released all the materials that they have submitted to FERC by including them on their website, FERCLitigation.com. Thus, the materials are in the public domain and FERC does not need to give Powhatan and Huntrise any prior notice before releasing or commenting upon the materials. We further request that you direct Mr. Bay to publicly release all information from the investigation regarding Powhatan and Huntrise.
