## MOTION OF NONPARTY TO QUASH AND FOR PROTECTIVE ORDER

Pursuant to Rule 45(c)(3) of the Federal Rules of Civil Procedure and the Initial Pretrial Order issued December 12, 2021 (ECF No. 160), nonparty Monitoring Analytics, LLC, acting in its capacity as the Independent Market Monitor for PJM ("Market Monitor"), moves to quash Defendants' subpoenas for depositions of two Market Monitor staff, Dr. Joseph Bowring, President, and John Dadourian, Senior Analyst, and for a protective order governing the depositions of Dr. Bowring and Mr. Dadourian by Defendants and Plaintiff. The Court should quash the subpoenas and issue a protective order because of the undue burden the subpoenas impose on the Market Monitor and to protect the Market Monitor's confidential information.
